## Tom Cotton (R)

### BIOGRAPHY



**Biography:** As a boy, Tom Cotton had dreams of becoming a teacher. That changed in the early 1990s when he watched fellow Arkansan Bill Clinton's political coming out party and got hooked on politics. Like Clinton, Cotton is an Ivy-League-educated rising star in his party. Unlike Clinton, his school of choice was Harvard, and his party of choice is the Republicans. Cotton grew up on his family's cattle farm in rural Dardanelle. Although his family wasn't politically active,

they were staunchly conservative, and Cotton absorbed their values. After finishing undergrad work and law school at Harvard, he clerked for the U.S. Court of Appeals and then went into private practice. Moved by the events of September 11, 2001, Cotton joined the U.S. Army in 2004. Rather than serve as a JAG as was expected of him, he volunteered for the infantry. In Baghdad, he led daily combat patrols for his 41-member air-assault infantry platoon. When he returned home, he was assigned to the Arlington National Cemetery, where he conducted honors for military funerals. He was back on the frontlines again in 2008, this time in Afghanistan, where he planned operations for an even larger counterinsurgency team. During his two tours of duty, he amassed some impressive hardware, including the Bronze Star Medal and the Iraq Campaign Medal. Once his service ended, Cotton headed to Washington, D.C., where he worked as a management consultant, advising clients on business strategy, marketing, finance and operations. Cotton considered running for a seat in the U.S. Senate in 2010, but deferred until 2012, when he took a run at the newly-redrawn 4<sup>th</sup> Congressional District and made short work of his Democrat rival. Citing his impressive background and his vocal, informed condemnation of the sequester, *Politico* recently named him "Most Likely To Succeed" among the freshman class of the 113<sup>th</sup> Congress.

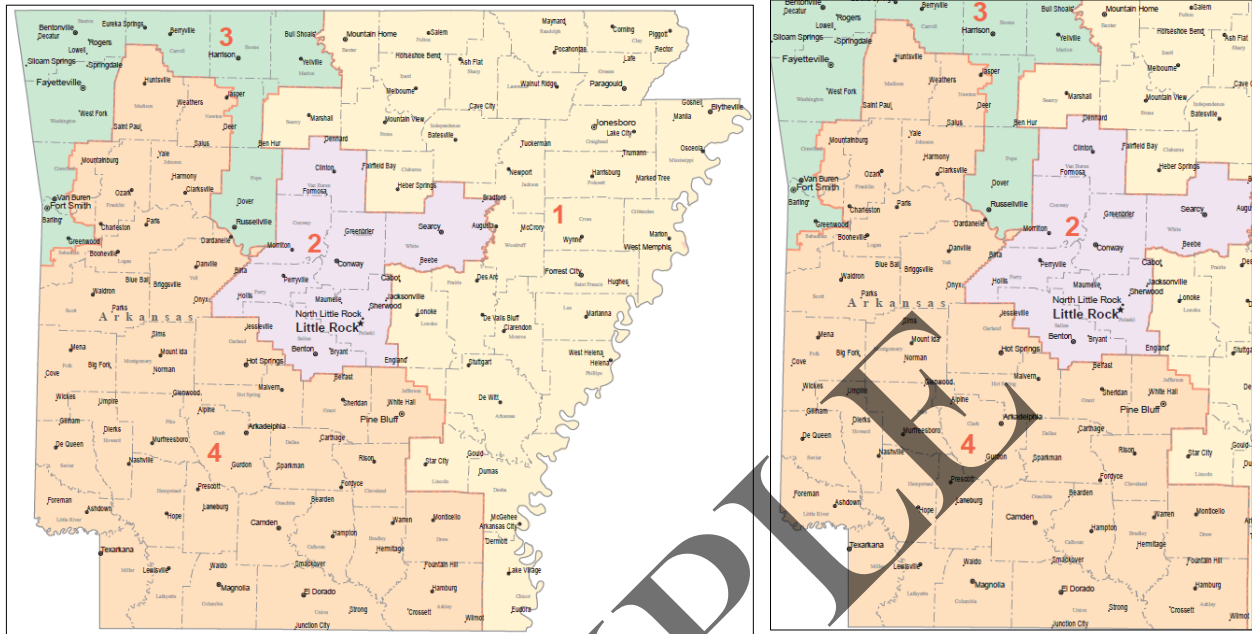
### LOCAL COVERAGE

**Cotton Promises To Let The Constitution Guide His Decisions.** "I believe the constitutional structure is an essential safeguard of liberty. I will keep faith with my oath to defend the Constitution by reviewing proposed laws for constitutional defects. I will never pass the buck to the courts by voting for a law that I believe is unconstitutional—if a proposed law is unconstitutional in my judgment, then I will vote against it."
